That's probably going to become a usual practice for the January TAC since everyone is going to continue to 17 be on vacation. But just be aware we will be sending the e-mails out for 18 19 the February TAC so your responses will be put into the packet and then up for discussion again at that time. So thank you Mr. Chair. 20 21 22 Gwynne: Okay. So we'll still accept the verbal updates at this point? 23 24 Yes. Yes. Wray: 25 26 Gwynne: Okay. 27 28 Wray: By all means. 29 30 Gwynne: Okay. City of Las Cruces. 31 32 Trevino: Mr. Chair. In regards to the LC00130, the El Paseo Safety project, the 33 concurrent letter has been received from NMDOT and the contracts are 34 currently in the hands of the contractor awaiting signatures so we can 35 proceed with construction. 36 LC00190 which is the Las Cruces Dam Trail project is also, we've 37 also received the concurrence letter from NMDOT and those contracts are 38 also in the hands of the contractor awaiting signatures so we can proceed 39 with construction. And that is it for our two projects. 40 41 Gwynne: Okay. Dona Ana County. 42 43 Molina: And I'll have to, I don't have the LC number but I did submit a, the, an e-44 mail to you Andrew so you should've got it. Regardless Dona Ana, oh I'm 45 sorry, Dripping Springs, that project Dripping Springs/Baylor Canyon is 46 actually under construction. What's happening right now is just

1 construction staking so you will see some activity in the weeks to come. 2 And the Dona Ana School and Camino Real intersection, it's still design. 3 Right-of-way take is where, where we're at. And with that I'll leave it, you 4 know if you all have any questions please feel free to ask. Thanks. 5

- 10 Okay. Las Cruces Public Schools. Gwynne:
- 12 We are, are focusing right now on our education at elementary schools on Gregory: 13 pedestrian safety and, and crossing and walking to school. We did just 14 present a pedestrian and a bicycle awareness safety to all the school bus drivers which is about 200-plus bus drivers, just about who has the right-15 16 of-way when they're around the streets and in these corridors so we're also working with the City and picking up some of our meeting dates to 17 update our Safe Routes to School Action Plan. That's been, we've had a 18 couple of meetings, had some good work on that so we're going to 19 continue to do that and try to get that done pretty quickly here hopefully. 20 And that's, and we're still continuing our weekly and monthly walking 21 22 events at the schools also.
- 24 Gwynne: Okay. RoadRUNNER Transit.
- 26 Bartholomew: We're still working on trying to move forward with the new service plan 27 design. The MPO is going to be doing a work session before the Las 28 Cruces City Council of the, of the plan and also what the cost will be for 29 the, the conversion with moving bus stops, bus shelters, everything related to, to the cost of converting to the, to the new service. That's going 30 to be what is it, one in the afternoon on the eighth of February? 31
- 33 Murphy: That's correct.
- 35 Bartholomew: Will be that presentation. Also because there are a couple new members on the City Council as well that will be a good introduction to, to the City 36 Council. And as far as projects that are in the TIP the one, I think is 37 38 TL00013 we're going to increase in, in Fiscal Year 2016 the budget for what we didn't obligate of 2015 monies. This, this is the 2/12ths that 39 Congress obligated, or appropriated at the very last moment when, when 40 we'd already had our other grant in and if anybody knows that works with 41 FTA websites right now. They're switching grant management systems 42 and they, their old one is offline and their new one isn't online yet so we're 43 44 not able to apply for that. So it'll have to be applied for in 2016. 45
- Okay. Is there anyone here from Regional Transit District? 46 Gwynne:

1 2 Armijo: Hi. And we've had quite a bit of activity in the last 30 days. We're now 3 planning to have a, a Committee meeting next week in which we'll make 4 final decisions on the routes and the date that we actually roll out, 5 although I expect that day will probably be the second week of October. 6 We've worked through all the schedules. We've got the buses here and 7 as you can see, one outside. We also have the bus stop actually are 8 starting to go in. I, we're very excited, I got my first commendation this 9 week and my first complaint. So the service is not even running but we're 10 getting accommodations for people who are very excited in the area around Vado. But the route should go forward pretty well. There's a 11 12 number of activities being done with that. On a separate note we're also, 13 have launched kind of a refresh of the passenger rail study that we did 14 about five, six years ago in this area and I did talk to, with our consultant over the holidays and began moving data to them so I think I've asked the 15 16 MPO for some assistance on that as well. It's a very interesting project. 17 We expect that we will be in the area with a consultant team and some 18 local consultants beginning some time in, again also about mid, mid-February and right now we're working on a schedule as to what the 19 20 community engagement will be and how we'll go into the community and talk a little bit about what the opportunities are for that service. I hope to 21 22 have some time in the next few weeks to actually talk to the other MPO in 23 El Paso cause I think they're, might be involved with this as well. So a lot 24 of activity going on and we'll hope to give you more information and 25 update by this time next month. Hopefully we'll actually be in service. 26 Thank you.

projects that are going on. There's still a little bit of work on North Main.
They're doing punch list items right now that hopefully they should be
done quickly on that. You'll still notice some intermittent lane closures at
various times but we hope to be done soon.

- The Missouri bridge project is moving along very well. There was a little bit of a delay on delivery of the beams for the bridge but that has been taken care of so the contractor is really ramping up again on their work. There's going to be some closures on Missouri as the bridge work continues but we hope to be done with that contract by the end of March.
- 44 The Union/Ramp E/I-10 project is just about halfway done. I didn't 45 get a chance to talk to the project manager so I don't exactly know what

The project on I-10, the mill and inlay from Jackrabbit to the I-10/I- 25 interchange, the contractor is working on milling the westbound lanes right now. The next phase of that sort of same contract is from the I-10/I- 25 interchange to the Texas state line and the same contractor got that portion so they'll be working up to the Union/Ramp E traffic control, stopping, moving on to the six-lane, and then coming back after Union and Ramp E is done and finishing up that. So I-10, excuse me I-10 all through town to the Texas state line should be done by the end of 2016. And that's all I have unless there are specific questions.
