 the 2016-2021 Transportation Improvement Program and I believe that's
 going to be presented by MPO staff.
- Wray: 32 Thank you Madam Chair. On page 10 of the packet we have one of the 33 amendments being requested. This is to the Valley Drive project. The 34 City of Las Cruces has contributed funding for utilities work along the 35 project as they would like to do utilities at the same time that NMDOT is doing the construction of the road. It's also my understanding that 36 NMDOT has a floor amendment that they would like to offer so I'll hand 37 38 the floor back to the Chair. 39
- 40 Herrera: Thanks Andrew. Yes, so after I submitted the information for this TIP 41 amendment we received some news on the funding that we have for 2018 and we need to move one of the projects that was programmed in the TIP 42 I believe you all received a handout for the updated 43 back a year. 44 spreadsheet. That's control number LC00300. It's a pavement 45 preservation on US-70 from Elks to Del Rey and we need to move that back one fiscal year to FY2019. 46

3 4		we just received, LC00160, the termini shows that it's Picacho to Avenida de Mesilla. Yet on page 10 it shows the termini as Valley Drive from

6		limits to the south, those two descriptions don't jive.

41	Murphy:	Thank you Madam Chair. We received notification from NMDOT Transit
42		and Rail that we're going to be having a substantial carryover amount of
43 44		our FY16 monies and we needed to amend the UPWP to reflect that and we're going to be adding a project into that, or we'll be adding a couple of
44 45		things that we'll be proposing to spend that money on. First, we're
46		proposing to spend in the neighborhood of \$25,000 depending on bid
-		

1 pricing for some software that would aid us in the dissemination of data collected by the automated passenger counters that we've installed on two 2 RoadRUNNER Transit buses. The second item that we are planning on 3 4 spending the carryover amount would be joining in with the City of Las 5 Cruces on their Active Transportation Plan. So we'd be adding 6 approximately \$32,000-\$33,000 onto that effort of securing a contractor 7 who will then evaluate the area's deficiencies and develop a plan for 8 correcting the deficiencies along bicycle and pedestrian standpoint. And with our money in there we're going to be requiring a distinct focus of 9 10 those deficiencies, how they relate to transit stops. And then we're also making one other change. This is mainly to do with staff time, on page 21 11 12 of the packet. We're going to be discontinuing efforts to enhance the 13 Coordinated Human Services Transportation Action Plan. There currently 14 exists a larger plan for the Council of Governments region which includes our area and the El Paso MPO area. The aim was to dive down deeper 15 16 into that, get a more nuanced document that was fitting in the area. However, our initial outreach to stakeholders found very little interest in 17 developing such a plan so we're removing that as a work item in our 18 19 UPWP. And then on page 23 has essentially the adjustment of the 20 funding amounts to reflect the additional \$66,910 and plus the approximately \$16,000 local match. And with that I'll stand for any 21 22 questions.

 jurisdictions and then we'll move on to MPO staff and then other
 Committee comments. So let's start with the City of Las Cruces.

1 2 Trevino: The Las Cruces Dam Trails, LC00190 is at a standstill, or not at a 3 standstill. We're awaiting additional approval for some change orders due 4 to some erosion that's occurring along the trail in some areas. So once 5 that gets going we'll be able to get construction back on track and finish it 6 up, so hopefully within the next couple months we'll be done with that one. 7 That's all I have. 8 9 Thank you. Dona Ana County. Any updates? Herrera: 10 Sure. Yes ma'am. Good afternoon. Yeah, actually a note officially today, 11 Marmolejo: 12 the 2nd, if you're all familiar with the Las Cruces Extraterritorial Zone, it's 13 gone. There's no more ETZ. All the subdivisions have been shifted over to the Community Development Department so as far as agency reviews, I 14 know the Town of Mesilla if there's something nearby you all, you would 15 16 be a reviewing agency and Las Cruces Public Schools would be a reviewing agency, City of Las Cruces would be a reviewing agency, so 17 depending on where that subdivision is you all would be receiving agency 18 19 review requests from us. So that's it for the ETZ. MPO too as well. 20 Thank you. 21 22 As part of that it also puts into effect the County's Unified Development Gwynne: 23 Code. So that's all part of the Viva Dona Ana process that's been going 24 on for guite some time, so today's the effective date. 25 26 Herrera: Okay. 27 28 Okay, if there is a subdivision within that three-limit boundary, City of Las Trevino: 29 Cruces will still get a review? 30 Marmolejo: That's correct. Yes sir. 31 32 33 Trevino: And then who would be the deciding factor if there's kind of a conflict in 34 comments regarding some of the ... 35 36 Marmolejo: Typically what happens with subdivisions, we send the review out and if 37 there's a comment issue we would do like a DRC as well. So there'll be a 38 chance like if you all have a comment as an issue we would move, if it 39 can't be resolved we would go to DRC and then DRC would make a 40 recommendation on the next step to the Planning and Zoning 41 Commission. 42 43 Trevino: Thank you. 44 45 Herrera: Any other questions/comments? No. Town of Mesilla do you have any updates? 46

7.2 NMDOT Projects Update

- 14 Herrera: Let's move on to NMDOT project updates.
- 15 16 Chavarria: We're going to be starting here pretty soon this week is 1100570 which is 17 a pavement preservation just on the other side of Organ Pass to the County line. That's going to be 80 weather working days, so about four 18 19 months. LC00120 which is the US-70/Spitz/Solano intersection, it's been 20 bid. We're waiting to award that project but should be starting this 21 summer sometime. And just south of us we have two small bridges over 22 EBID laterals on New Mexico 28 and New Mexico 186 and those projects 23 should be completed March of this year. And that's all I have for ongoing 24 projects right now.
- 25 26 Herrera: I want to add some of the projects that are coming up soon or are in the 27 final design stages. The first one is LC00240, that's the shoulder widening project from Organ to basically the White Sands exit. That one is going to 28 29 production in February so we're doing final documents now. The PS&E here is in a couple of weeks and that one's on schedule. Everything looks 30 good. So you should start seeing cones out there probably late summer 31 on that one. The other big one is Valley Drive. We kind of talked about it 32 33 a little bit but that one is still scheduled for a May let date and we're on 34 schedule for that. So those are the two other big ones in the area that are 35 upcoming this fiscal year. Next fiscal year we have the University/I-25 36 interchange project so we're rebuilding the bridges, basically reconfiguring that entire interchange. That's a really big \$25 million project but that's not 37 38 scheduled to let until October of 2018. So we have a while on that one. 39 But we'll be doing more updates as we get closer. Anything else, Aaron? 40
- 41 Chavarria: Yeah. I got one more. US-70 and 17th Street. It bid last month so we
 42 should see, that's a signalization at that intersection so we should see
 43 some work begin there this summer. Thank you.

Decision record will be signed probably tomorrow on the NEPA work and then hopefully we'll be in a position to afford a offer of right-of-way to the County. Thank you.

- McAdams: On the 17th and the 25th there were public hearings at the Mesilla Valley
 Transit Center which we discussed some revisions of routes. There'll be a
