**A RESOLUTION APPROVING THE 2021 TRANSPORTATION PROJECT FUND (TPF) APPLICATIONS FROM MESILLA VALLEY MPO MEMBER JURISDICTIONS**

The Mesilla Valley Metropolitan Planning Organization (MPO) Policy Committee is informed that:

**WHEREAS**, on April 15, 2021 the New Mexico Department of Transportation (NMDOT) published a call for projects for the State of New Mexico Transportation Project Fund (TPF); and

**WHEREAS**, the Transportation Project Fund regulations require MPOs to review and authorize TPF projects from the MPO planning area; and

**WHEREAS**, various Mesilla Valley MPO member jurisdictions wish to submit projects to be considered in the TPF process; and

**WHEREAS**, this resolution authorizes MPO Staff to submit these projects to NMDOT for consideration in the TPF process; and

**WHEREAS**, the Policy Committee has determined that it is in the best interest of the MPO for this resolution to be APPROVED.
