RESOLUTION NO. 26-05

A RESOLUTION AMENDING THE MESILLA VALLEY MPO BYLAWS

The Mesilla Valley Metropolitan Planning Organization (MPO) Governing Board is informed that:

WHEREAS, the Mesilla Valley MPO is created by a Joint Powers Agreement between the City of Las Cruces, Doña Ana County, and the Town of Mesilla; and

WHEREAS, the Mesilla Valley MPO adopted a new Joint Powers Agreement in 2024; and

WHEREAS, the State of New Mexico requires the Mesilla Valley MPO to maintain bylaws to govern the MPO board, committees, and operations; and

WHEREAS, the above referenced revisions to the Mesilla Valley MPO's Joint Powers Agreement require revisions to the in-force version of the MPO Bylaws; and

WHEREAS, the MPO Executive Committee has reported out a revised draft of the MPO Bylaws; and

WHEREAS, additional beneficial changes for the good operation of the MPO are proposed in this draft; and

WHEREAS, the Bicycle and Pedestrian Facilities Advisory Committee recommended approval of the revised MPO Bylaws at their May 19, 2026 meeting; and

WHEREAS, the Technical Advisory Committee recommended approval of the revised MPO Bylaws at their June 4, 2026 meeting; and

WHEREAS, the Governing Board has determined that it is in the best interest of the MPO for this Resolution amending the MPO Bylaws to be approved.

NOW, THEREFORE, be it resolved by the Governing Board of the Mesilla Valley Metropolitan Planning Organization:

(I)

THAT the draft contained in Exhibit "A", attached hereto and made part of this resolution are APPROVED as the new Bylaws for the Mesilla Valley Metropolitan Planning Organization.

(II)

THAT all previous versions of the Mesilla Valley MPO's bylaws are superseded and replaced by these bylaws.

(III)

THAT these Bylaws take effect immediately upon adoption.

(IV)

THAT staff is directed to take appropriate and legal actions to implement this Resolution.
